Dear Ms. Liu:

We, the 312 undersigned stakeholders, write this letter in response to recent election results of our Central Hollywood Neighborhood Council (CHNC) and to challenge the conduct and the outcome of the CHNC Board Elections held on Sunday, March 30, 2014 at Hollywood Constituent Center, 6501 Fountain Avenue, Hollywood, CA 90028.

As described in the EmpowerLA, Department of Neighborhood Empowerment 2014 Election Manual, dated December 17, 2013, any stakeholder who submits the same stakeholder documentation required of the voters in the election may file a challenge to the conduct of the election no later than five (5) calendar days after the election by filing a written request with the Department.

We challenge the election based on the following reasons:

1. The spirit if not the letter of the law (City of Los Angeles Ordinance No. 174006, Section 3 c 1) has been disregarded. This section reads in part:

The governing body must, to the extent possible, reflect the diversity of the neighborhood council's community stakeholders. No single stakeholder group may comprise a majority of the neighborhood council's governing body, unless approved by the Department upon a showing of extenuating circumstances.

The five candidates elected on Sunday March 30, 2014 represent the same stakeholder group as documented in their Candidate Filing Forms (Exhibit I) and constitute a majority of the 9-seat CHNC Governing Board.

2. Section VII. Candidates A-2 of the above-referenced election manual states in part:

All potential candidates must provide identification and any other applicable documentation to establish their stakeholder status for the position which they are applying.

One of the candidates elected on Sunday, March 30, 2014 established their stakeholder status by writing and signing their own letter of documentation (Exhibit II). Self-affirmation for candidates is prohibited by CHNC bylaws

A business license for Peru Village, Peru Village LA or PVLA has not been issued by the City of Los Angeles. As of April 2, 2014 the City of Los Angeles Office of Finance has no business records for Peru Village, Peru Village LA or PVLA as a community interest group, stakeholder group or business.

4. 355 Vote by Mail applications were filed with the City Clerk and only 167 were counted and included in the official canvas (Exhibit III). The letter that was included with the Vote by Mail Ballot stated erroneously that voters must return their VBM ballots by April 7, 2014, while the official return due date was March 28, 2014 (Exhibit IV). The correction letter was received on March 29, 2014, after the deadline. Additionally, many stakeholders never received their Vote by Mail Ballot.

The outcome of the election may have changed if the 188 ballots (the difference between the VBM applications and the number of VBM ballots counted) had been returned to the City Clerk by mail or at the Polling Place and/or if VBM ballots and been received by the VBM applicant.

- 5. Article XXI. Videotaping of the above-referenced election manual states: Videotaping and photography is permitted in the Polling Place on Election Day under the following conditions:
 - Video/Photography is only permitted with the expressed permission of everyone at the polling place.

The Poll Manager did not have a consensus of everyone at the polling place to give permission for Video/Photography

- 6. Article XII B Observers of the above-referenced elections manual states in part:
 - Observers may not talk to or solicit voters in the Polling Place.

Badges were not provided to the observer(s). On more than one occasion the Poll Manager had to stop the Observer from talking to several voters who couldn't remember the address they were supposed to use on their registration form.

7. From the EmpowerLA/DONE website:

- Neighborhood Councils are meant to include representatives of the many diverse interests in communities and have an advisory role on issues of concern to the neighborhood.
- The Department of Neighborhood Empowerment believes that citizen engagement in City government is important because no one understands a neighborhood better than the residents, business owners and property owners that make that neighborhood unique. It believes that neighborhood stakeholders can and should have a platform for advocating for the local issues they care about most and a forum for creating programs and events that unify the neighborhood and respond to community needs.

The five stakeholders elected on Sunday March 30, 2014 and the stakeholders that voted for them represent the same stakeholder/community interest group and each used the same apartment address at 5913 Gregory Avenue, #3, Los Angeles 90038. During the registration process these voters were unfamiliar with the community and the CHNC as attested to by

two stakeholders (Exhibit V). Voters from this group were cautioned by their friends/colleagues to use the "Hollywood Address" and not to use their home addresses.

- 8. Article XVI. Challenges of the above referenced elections manual states in part: Any area not listed above cannot be challenged, including:
 - Error in Voting Instructions
 - Voter Instructions

Our First Amendment rights to petition for a governmental redress of grievances may be violated by the list created by DONE of what is challengeable and what is not.

The First Amendment to the United States Constitution prohibits the making of any law respecting an establishment of religion, impeding the free exercise of religion, abridging the freedom of speech, infringing on the freedom of the press, interfering with the right to peaceably assemble or *prohibiting the petitioning for a governmental redress of grievances*. It was adopted on December 15, 1791, as one of the ten amendments that comprise the Bill of Rights.

We, the 312 undersigned and self-affirmed stakeholders of Central Hollywood Neighborhood Council challenge the conduct of the CHNC Board Elections held on Sunday, March 30, 2014. Further, to correct the defects cited above, we request that a new election be scheduled for Central Hollywood Neighborhood Council that will incorporate the adjustments noted above.
