# Mid City Neighborhood Council (MINC) Ballot Voting Model

The MINC Ballot Voting Model has twelve (12) different ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

## 1) AT LARGE BALLOT

Stakeholders who live, work, own property in the neighborhood or those who declare a stake in the neighborhood and affirm a factual basis for it and who are 18 years or older are eligible to vote for the following races:

- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 2) REGIONAL REPRESENTATIVE 1 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 1 can vote for the following races:

- Regional Representative 1 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

# 3) REGIONAL REPRESENTATIVE 2 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 2 can vote for the following races:

- Regional Representative 2 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

# 4) REGIONAL REPRESENTATIVE 3 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 3 can vote for the following races:

- Regional Representative 3 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 5) REGIONAL REPRESENTATIVE 4 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 4 can vote for the following races:

- Regional Representative 4 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 6) REGIONAL REPRESENTATIVE 5 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 5 can vote for the following races:

- Regional Representative 5 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 7) REGIONAL REPRESENTATIVE 6 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 6 can vote for the following races:

- Regional Representative 6 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 8) REGIONAL REPRESENTATIVE 7 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 7 can vote for the following races:

- Regional Representative 7 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 9) REGIONAL REPRESENTATIVE 8 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 8 can vote for the following races:

- Regional Representative 8 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 10) REGIONAL REPRESENTATIVE 9 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 9 can vote for the following races:

- Regional Representative 9 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 11) REGIONAL REPRESENTATIVE 10 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 10 can vote for the following races:

- Regional Representative 10 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

### 12) REGIONAL REPRESENTATIVE 11 BALLOT

Stakeholders who are 18 years or older who live or own residential property within Region 11 can vote for the following races:

- Regional Representative 11 Vote for one (1)
- Merchant/Commercial Property Owner Representatives Vote for up to five (5)
- At-Large Representatives: General Vote for up to four (4)
- At-Large Representatives: Organization Vote for up to three (3)

## **Summary:**

- The MINC has 23 board seats. All 23 are elected.
- Stakeholders will use **self-affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is 18.
- The MINC Board has a two year term.
- Candidates can run for more than one board seat.
