Mar Vista Community Council (MVCC) Ballot Voting Model

The MVCC Ballot Voting Model shall have seven (7) different ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

1) COMMUNITY DIRECTOR BALLOT

Stakeholders who live, work or own property within the stated boundaries of the MVCC and those who declare a stake in the MVCC and affirm a factual basis for it, and are 18 years or older, can vote for the following race:

Community Director – Vote for one (1)

2) ZONE 1 BALLOT

Stakeholders who live, work or own property within their respective stated geographic Zone boundaries, and who are 18 years or older, can vote for the following races:

- Zone 1 Director Vote for one (1)
- At-Large Directors Vote for up to six (6)
- Community Director Vote for one (1)

3) ZONE 2 BALLOT

Stakeholders who live, work or own property within their respective stated geographic Zone boundaries, and who are 18 years or older, can vote for the following races:

- Zone 2 Director Vote for one (1)
- At-Large Directors Vote for up to six (6)
- Community Director Vote for one (1)

4) ZONE 3 BALLOT

Stakeholders who live, work or own property within their respective stated geographic Zone boundaries, and who are 18 years or older, can vote for the following races:

- Zone 3 Director Vote for one (1)
- At-Large Directors Vote for up to six (6)
- Community Director Vote for one (1)

5) ZONE 4 BALLOT

Stakeholders who live, work or own property within their respective stated geographic Zone boundaries, and who are 18 years or older, can vote for the following races:

- Zone 4 Director Vote for one (1)
- At-Large Directors Vote for up to six (6)
- Community Director Vote for one (1)

6) ZONE 5 BALLOT

Stakeholders who live, work or own property within their respective stated geographic Zone boundaries, and who are 18 years or older, can vote for the following races:

- Zone 5 Director Vote for one (1)
- At-Large Directors Vote for up to six (6)
- Community Director Vote for one (1)

7) ZONE 6 BALLOT

Stakeholders who live, work or own property within their respective stated geographic Zone boundaries, and who are 18 years or older, can vote for the following races:

- Zone 6 Director Vote for one (1)
- At-Large Directors Vote for up to six (6)
- Community Director Vote for one (1)

Summary:

- The MVCC has 13 board seats. All **13** are elected.
- Stakeholders will verify their stakeholder status through written **Self-Affirmation**.
- Minimum stakeholder voting age is 18.
- The MVCC has six (6) voting zones within their boundaries.
- The MVCC Board has a two-year term.
- Candidates can run for no more than one Board seat.
