On April 12, 2014, an incident happened during Rampart Village Neighborhood Council Election 2014. While the election was going on, Cecilia Ramos of Historic Filipinotown Neighborhood Council Incorporated came in and acted like she was somebody who has the authority to do whatever she wants to do. She was getting copies for the registration election forms from the other pole workers, and then she was handing out these forms to the voters as she was also handing out copies of the slate of her handpicked candidates that she was promoting. When I told her that she was not authorized to do that, she confronted me and said that she already asked "the higher up, that told" her "that it was ok to do that" and she also added that she "did not have to ask for my permission." I saw her handing a copy of her slate to my co-poll worker. And as the voters were coming in, each one of them had a copy of her slate also. I gathered all these copies and handed them to Alicia Smith, the poll manager of the RVNC Election. She wrote my name down and my daughters too, as witnesses of this incident. Cecilia Ramos of the Historic Filipinotown Neighborhood Council, Inc. was in fact telling every Filipino voter that she could in Tagalog before she was stopped: "Alam na ninyo kung sino ang inyong bobotohin!" which in English means, "You already know who to vote for! "Upon learning of this incident, the poll manager asked her to leave the room. She complied after defending her actions as "just trying to help" and before any further action had to be taken like calling the police. I then witnessed Cecilia Ramos of Historic Filipinotown Neighborhood Council, Inc. sit at the RVNC Outreach booth that was just at the 100 feet mark from the poling area's front door for most of the of the 8hr election where she was campaigning for her

slate of candidates at the RVNC table even after the tent blew down she remained in the sun like she had a strong purpose to control the results of this election in the RVNC.
